The European Marine Observation and Data Network (EMODnet) was created in 2009 to unlock fragmented and hidden marine data resources, making these available to individuals, organisations and businesses without restrictions.

EMODnet is a network of more than 120 partners supported by the EU's integrated maritime policy who work together to observe the sea, process the data according to international standards and make that information freely available online as interoperable data layers, data products and services.

The 'collect data once and use many times' philosophy benefits all marine data users, including policy makers, scientists, businesses and the public. Our European marine data sharing policy already saves costs for offshore and coastal business and offers a range of new opportunities for innovation and blue growth.

The Challenge...

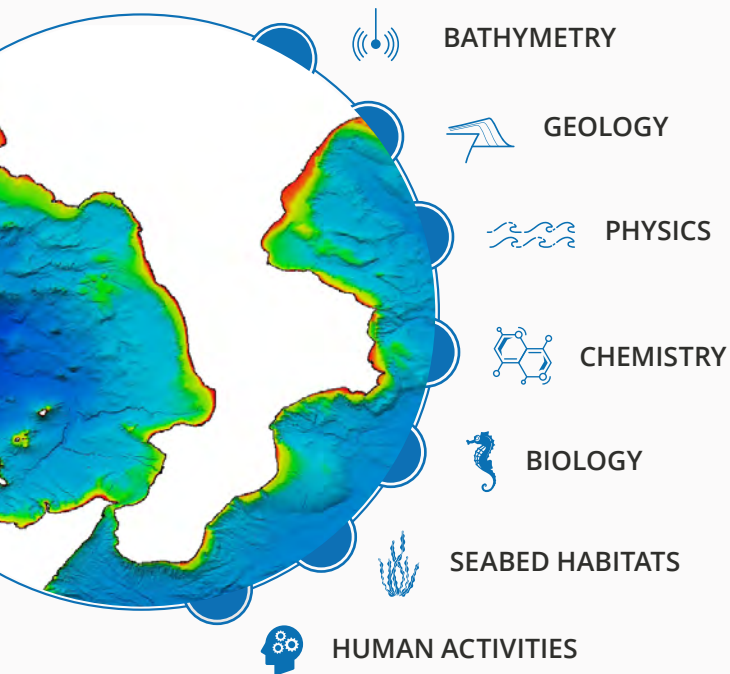
Data from the marine environment are a valuable asset. Rapid access to reliable and accurate information is vital in addressing threats to the marine environment, in the development of policies and legislation to protect the marine and coastal environments, in understanding trends and in forecasting future changes. Likewise, better quality and more easily accessible marine data are a prerequisite for continued sustainable economic development, so-called 'blue growth'.

Unfortunately, marine data collection, storage and sharing in Europe has been carried out in a fragmented way for many years. Data are often collected for a specific purpose, to meet the needs of a single private and/or public organisation, often working in isolation from each other and leading to duplications of effort, repeated sampling campaigns and unnecessary inefficiencies.

Central Access Portal

EMODnet provides a **single point of access** to European marine data across seven discipline-based themes:



Through these channels, users have access to reliable and standardised observations, metadata and processed data products such as basin-scale maps.

The EMODnet Central Portal (emodnet.ec.europa.eu) is the access point to these services, which are free to use and easily accessible.

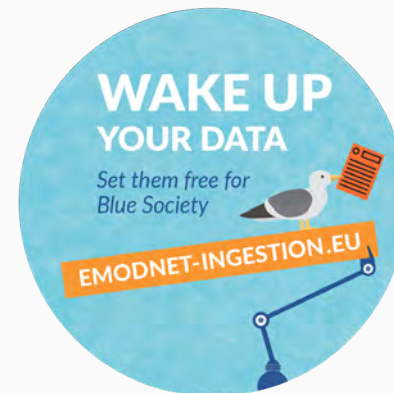
The EMODnet Data Ingestion Facility: Ready to free your data

There is a wealth of marine data collected in Europe by public and private users. Nevertheless, many data remain hidden or unusable.

EMODnet's Data Ingestion facility (www.emodnet-ingestion.eu) tackles these problems by reaching out to data holders, explaining the benefits of sharing their data and offering a support service to assist them in doing so.

The result is to increase the quantity and quality of available European marine data for re-use by diverse stakeholders.

EMODnet will continue to strengthen its collaboration with marine knowledge providers, including the science community, the marine component of the EU's Copernicus programme and the private sector, to create a common platform for marine data.
